Freestyle Canada Selection Criteria

1. INTRODUCTION

- 1.1 This document outlines how Freestyle Canada ("FC") will select the athletes to the Canadian Freestyle team for the 2023 FIS Freestyle World Championships Team in Bakuriani, GEO which will take place from February 18th to March 5th, 2023.
- 1.2 The selection criteria shall be interpreted and applied in accordance with the principles of procedural fairness and natural justice.
- 1.3 The freestyle ski disciplines that will take place in Bakuriani, GEO during the 2023 FIS Freestyle Ski World Championships include 15 events:
 - Men's & Women's Ski-Cross (selection managed by Alpine Canada)
 - Men's & Women's Moguls
 - Men's & Women's Moguls Dual Moguls
 - Men's & Women's Halfpipe
 - Men's & Women's Slopestyle
 - Men's & Women's Big Air
 - Men's & Women's Aerials
 - Mixed Team Aerials
- 1.4 Quota spots are allocated on February 6th, 2023, to the Disciplines (see point 3.8) of FC and Alpine Canada using the separate document: [22-23 WCh Quota Allocation System](#).
- 1.5 At present the FIS has not responded to a challenge set out by FC to interpret the rules. Should FIS clarify any items, those changes will be incorporated into this document. At present, the leading question is regarding the maximum team size of 36 athletes.

2. OBJECTIVES

- 2.1 The Canadian objectives at the 2023 FIS Freestyle World Ski Championships are:
 - I. To win medals for Canada at the 2023 WCh
 - II. To provide experience and international exposure to Canadian athletes identified as potential future medalists at the elite level.

3. DEFINITIONS

- 3.1 "FC" means Freestyle Canada, the National Sport Organization responsible for the selection of athletes to the Mogul, Dual Moguls, Aerial, Team Aerials, Slopestyle, Big Air and Halfpipe events.
- 3.2 "Athlete" means an International Ski Federation ("FIS") active member that is a Canadian resident or citizen as defined in the *Citizenship and Immigration Act* (Canada).



- 3.3 “WC”, “WCh” and “OWG” refer to the FIS World Cup events, the FIS World Ski Championships and the Olympic Winter Games.
- 3.4 “Eligibility Period” incorporates completed competitions (WCs, OWGs and other identified competitions which were valued for HPP selections during the Eligibility Period) held between October 1, 2021, and February 4, 2023. Results from the Eligibility Period are used to select athletes to the 2023 Canadian Freestyle World Championship team.
- 3.5 “FC Leadership” means any one of the following: High Performance Director (“HPD”), High Performance Manager (“HPM”), discipline head coaches, SSSMI Lead or any other individual that is designated as FC Leadership, from time to time, by FC;
- 3.6 “FC Medical Staff” is defined as the Integrated Support Team (“IST”) and made up of the following FC staff and contractors: Director - Sport Science Sports Medicine (“Director – SSSMI”), Lead Physician(s), strength and conditioning coaches, physiotherapists, and mental health practitioners;
- 3.7 “Fit to Compete” means an assessment by the FC Staff, in consultation with the FC Medical Staff, which ensures that an athlete is physically/psychologically ready to compete in the context of recovery from an injury. Factors that will be assessed include, physical fitness, exposure to risk of further significant injury, overall health, competitive readiness and consistency of training and performance prior to the Event.
- 3.8 “Discipline” refers to the following:
- Moguls = Moguls and Dual Moguls events
 - Aerials = Aerials (includes Mixed Team Aerials)
 - Halfpipe = Halfpipe
 - Slopestyle = Slopestyle and Big Air events
 - Ski Cross = Ski Cross (managed separately by ACA)

It is recognized that there are male and female competitions in each discipline. It is also recognized that athletes selected in the Disciplines of Moguls and Slopestyle are subsequently exclusively eligible to compete in Dual Moguls and Big Air. Athletes selected in Aerials may be internally selected to compete in the Mixed Team Aerial event.

- 3.9 “FC Selection Committee” for each Discipline includes:
- Voting members: FC’s HPDs, head or lead coach of specific discipline
 - Consulting members: FC’s CEO, Director - SSSMI, HPM. Other FC experts may be consulted on specific selection issues.

4. GENERAL ELIGIBILITY

To be eligible for Canadian Freestyle Team selection to the 2023 FIS World Ski Championships, an athlete must:

- Be a member of the 2022/2023 FC High Performance Program. For Mixed Team Aerials, the third athlete (only) may be a NextGen B identified skier if only one male and one female athlete are eligible for selection)
- Be a member in good standing with FC
- Have a valid FIS license and athlete insurance
- Be able to obtain a valid Canadian Passport (that meets the requirements of the World Championship Organizers published guidelines).



- Meet the minimum required FIS points as per the FIS Rule precisions specific to the FIS Freestyle Ski and Snowboard WSC 2023.

5. FIS POINT ELIGIBILITY FOR INDIVIDUAL ATHLETES

FIS has identified specific minimum FIS point level each athlete needs to meet to be eligible for participation in the 2023 World Championships.

* Subject to FIS rule changes

* Slopestyle and Big Air athletes need to meet the points eligibility in Slopestyle; Big Air FIS points will not be eligible.

* Big Air and Slopestyle results will be considered in FC athlete selection process. See section 8.4 for details.

6. TIMELINES

7. AVAILABLE FC QUOTAS

The FIS determines the maximum number of athletes that may compete at the 2023 FIS Freestyle Ski World Championships for each country participating and provides “quota spots”. The Canadian team quota spots are shared between ACA and FC for the Freestyle Skiing disciplines.

The FIS has established the following quotas for the 2023 FIS Freestyle Ski World Championships:

- I. Maximum of four (4) athletes per gender, per discipline.
- II. Maximum team size of twenty (20) athletes per gender.
- III. Overall maximum team size of 36 athletes (excluding current reigning FIS World Champions).
- IV. FIS will independently set the maximum number of men and women “Slopestyle and Big Air” quota spots through their separate process; the Canadian Slopestyle and Big Air athletes need to fit into the gender maximum and team maximums (outlined I points II and III, above).

The number of available quota spots for each Event Group will be determined on February 6th, 2023. Canada will have the ability to allocate a maximum of four (4) quota spots to each Event Group, plus an additional spot for any reigning World Champions. Mikael Kingsbury won both Moguls and Dual Moguls at the 2021 FIS Freestyle Ski World

Ski Championships and will be granted entry into both events at the 2023 Championships; he will not be counted in



the gender or team size maximums.

SS/BA Nations Quotas: For the Slopestyle and Big Air events, all nations will qualify quota spots by gender through the 4th Freestyle/Freeski FIS Points List 2022/2023. To qualify SS/BA spots for Canada, men need to be ranked in the top 60 and women need to be ranked in the top 30. SS/BA Nation Quotas will be determined by November 17th, 2022, at that point FC will be notified of the number of spots for the Slopestyle and Big Air events; these spots will be confirmed by December 18th, 2022.

FC and ACA are not required to fill all available quota spots in any one Discipline. If there are more quota spots for a selection group than eligible skiers in that group, the spot will go back to the pool and will be distributed to the next ranked Discipline/Gender that hasn't yet achieved their maximum of four spots.

8. DISCIPLINE SPECIFIC SELECTION CRITERIA

Each Event Group (Moguls, Aerials, Halfpipe and Slopestyle/Big Air) will select athletes to their available quota spots based on the criteria in this section.

8.1 Mogul specific team member selection:

One men's team and one women's team will be selected for the "Mogul" events. All selections will be undertaken on February 6th, 2023. To be eligible for selection, MO athletes must meet all eligibility requirements (Sections 4 and 5).

- Mogul selections will be based on the table in Appendix 1 into available quota spots.
- Both Mogul and Dual Mogul results from the Eligibility Period will be counted in the ranking for selections.
- One team will be selected for each of Men's and Women's Moguls: athletes selected for "Moguls" will be entered into each of the Mogul and Dual Mogul events.

8.2 Aerial specific team member selection:

This Aerial section will outline the process used to select men's and women's aerial team athletes into available quota spots for their individual events as well as how members will be chosen for the Mixed Aerial team event out of the pool of WCh team athletes.

- Minimum skill levels to be considered for selection:
 - **Men's event:** Competed on snow with two different jumps – minimum of double twisting double (i.e., bFF)
 - **Women's event:** Competed on snow with two different double jumps
 - **Team event:** The minimum skill level for the third Mixed Team Aerial skier is one double (i.e., bLT). An athlete identified in the RBC Training Group may be considered for team selection if there are not sufficient athletes in one gender to make a team from the High Performance Program.

8.2.1 Aerial (individual event) team member selection:

One men's team and one women's team will be selected for the individual "Aerial" events. All selections will be undertaken on February 6th, 2023. To be eligible for selection, AE athletes must meet all eligibility requirements (Sections 4 and 5).

- Athlete selections for the individual Aerial events will be based on the table in Appendix 1 into available quota spots.

8.2.2 Mixed Team Aerials (AET) team member specific selection:

FC's objective is to win a medal by fielding a team that can combine the scores from three landed jumps that lead to the highest possible combined jump total. Three



athletes will be selected for the Mixed Aerial Team from athletes who have been named to the FC World Championship team in the Aerial event.

- The Mixed Aerial Team will be composed of:
 - I. The highest ranked female Aerial athlete on the World Championship Master Ranking List
 - II. The highest ranked male Aerial athlete on the World Championship Master Ranking List
 - III. The third team member will be selected based on their ability to maximize the score in the Mixed Team Aerial Event. Rankings will be calculated using:
 - one list (men and women combined).
 - each athlete's highest average total jump score of his or her three of their five most recent WC competition jumps. cores must come from inside the Eligibility period.
 - the Selection Committee can substitute an athlete in the event of an injured athlete or if there is a reason the selected athlete is not able to perform; if the committee chooses this course of action, it must be documented in detail.

8.3 Halfpipe (HP) specific team member selections:

One men's team and one women's team will be selected for the "Halfpipe" events. All selections will be undertaken on February 6th, 2023. To be eligible for selection, HP athletes must meet all eligibility requirements (Sections 4 and 5).

- Up to four spots per gender will be selected, quota determined in the "Canadian Team Quota Allocation System."
- The Halfpipe World Championship Ranking list will be based on results as ranked through the Spot Allocation Tiers, details in Appendix 1.
- Tier 1 Events held during the Eligibility Period will be considered:
 - a. FIS World Cup events,
 - b. Olympic Games and
 - c. X-Games

8.4 Slopestyle and Big Air (SS/BA) specific team member selections:

One men's team and one women's team will be selected in the Discipline for "Slopestyle and Big Air": athletes selected to the "Slopestyle and Big Air" teams will be entered into both events. All selections will be undertaken on February 6th, 2023. To be eligible for selection, SS/BA athletes must meet all eligibility requirements (Sections 4 and 5).

There are two processes, per gender, for SS/BA World Championship team athlete selection:

- Up to three (3) spots will be selected based on results (SS/BA Results Based Selection)
- If a fourth spot is available, it will be selected using the Skill Assessment Selection process, described below.
- **SS/BA Results Based Selection** (up to three spots per gender):
 - The first three available Slopestyle and Big Air quota spots (per gender) will be filled by calculating each eligible athlete's three best eligible SS or BA placing values (obtained during the Eligibility Period). Each athlete will be listed on the SS/BA World Championship Ranking list with the sum of their three best placing values; the athlete with the highest sum will be ranked first; each remaining athlete will then be ranked based on their sum in descending order (details available in Appendix 2 and Appendix 3).



- Each athlete's three best results may come from any combination of Slopestyle and/or Big Air events and must be in the top 2/3 of the field size.
- Events Considered for SS/BA Ranking Based Selections:
 - Only Tier 1 classified events (Appendix 3) will be included in the ranking process.
 - Only events within the Eligibility Period will be considered
 - Tier 1 Field Size requirements:
 - Men's events must have a minimum of 30 athletes to be considered.
 - Women's events must have a minimum of 15 athletes to be considered.
 - X-Games and OWG full field sizes will be considered.
- **Skill Assessment Selection** (only if a fourth spot is available in either gender)
If a Slopestyle and Big Air Event Group qualifies a fourth spot, any remaining eligible athletes who were not selected through the *SS/BA Results Based Selection* will be considered for selection through this *Skill Assessment Selection* process (Appendix 2).

With the goal for each selected athlete to reach the finals at the WCh, the Skill Assessment selection process allows FC to recognize an athlete with newly mastered top-level skills. There is a dynamic, weekly evolution of skills in Slopestyle and Big Air events. During the time it takes to master a new skill, an athlete may sacrifice competition results and miss qualifying through the Results Based Selection process. If available, FC will fill the fourth spot an athlete who has proven they are performing skill that are in contention with a top-level performance by assessing the current skill level of athletes.

- Ranking and selection of eligible athletes in the skill assessment:
 - Rankings will be based on the total scores in the Slopestyle and Big Air assessments using the tool; the overall score for each athlete will be ranked from highest to lowest score. The athlete with the highest assessment score will be selected.
 - Skill Assessments are based on observations between October 1, 2022, and February 5, 2023 (note: only the 2022-23 season, not the full Eligibility Period).
 - The Skill Assessments will be completed by the three Slopestyle – Big Air World Cup Team coaches and verified by the HPD.
 - Skill Assessments will be completed in coordination with the World Championship Team selection meeting on February 6th, 2023.

9. TIMING AND APPROVAL

- 9.1 FC Selection Committee shall conduct the Selection meetings, on February 6th, 2023, following the last World Cup competition of the Eligibility Period.
- 9.2 Selections will be forwarded to the FC CEO for final review.
- 9.3 The FC Leadership Team, immediately following final approval, will notify those athletes that were eligible for selection, whether those athletes were selected, or not.

10. UNFORSEEN CIRCUMSTANCES & REVISIONS

- 10.1 In situations where unforeseen circumstances do not allow the selection process to be applied in the manner set out in this policy, FC Leadership Team reserves the right to determine an appropriate course of action and has the final decision-making authority.



- 10.2 The FC Leadership Team may exercise discretion to revise this agreement prior to the end of the Eligibility Period with any revisions as may be reasonably necessary to avoid disputes over the interpretation of the Selection Process. This clause shall not be used to justify changes after a competition or trials which formed part of these Team Selection Criteria unless it is related to an unforeseen circumstance. This is to allow for changes to this document that may become necessary due to a typographical error or a lack of clarity in a definition or wording.
- 10.3 The FC Leadership Team may, at any time, and at his/her/their discretion, disqualify an athlete from being considered for selection to the Team based on current or past behavior of the athlete which is inconsistent with FC's Code of Conduct. A copy of the Code of Conduct is available in the FC Athlete Agreement. FC will advise the affected athlete of this decision.
- 10.4 An athlete will be removed from consideration if he/she is in violation of any anti-doping policy or procedure as outlined by FC, International Ski Federation (FIS), World Anti-Doping Agency (WADA), and the Canadian Centre for Ethics in Sport (CCES).

11. HEALTH INTERRUPTION OF COMPETITIVE ACTIVITY

If an athlete is injured during the 2022-23 season and is unable to compete in 50% or more of the eligible events, they may have up to three results from the 2021-22 season included in the calculation of their WCh discipline specific selection rank. In addition, the athlete must:

- have started in at least one eligible event in the 2022-23 season (does not need to have that result included in the calculation).
- have FC Medical Staff documentation of the injury.

Only top 2/3 results will be considered for these calculations.

12. APPEALS

Appeals regarding the 2023 FIS Freestyle Ski World Championships will need to be completed in an expedited manner. For this purpose, FC will defer any selection dispute to the SDRCC instead of using their own published appeal policy.

- 12.1 Any dispute in relation to the 2022-23 WCh selection process must be brought directly to the SDRCC to be heard pursuant to the Canadian Sport Dispute Resolution Code.
- 12.2 An athlete who wishes to appeal the team selection shall, within two calendar days commencing from the day following the release of the public team announcement, file an appeal with the SDRCC. The athlete shall provide the FC CEO with their intent to file as soon as they have made this decision.
- 12.3 Appeals will not be accepted past this time frame.

Ranking Criteria Notes:

- Event values will be established after the event is complete to ensure accurate values are used for final rankings
- Values of events can be changed throughout the season. This would be done to ensure the events are fairly valued comparatively with all events throughout the season
- The selection committee reserves the right to determine that an event will not be recognized for ranking or selection purposes up to two weeks prior to the first training day
- Within two weeks after completion, an event will be valued and may be shifted into a different tier to accurately value the event
- Value of events are determined as follows:
 - The HPP Selection Committee will determine the value of the Tier 1 events
 - The HPAD advisory group will value the Tier 2 and Tier 3 events.
 - These committees may decide to add eligible events with a minimum of 3-weeks' notice prior to the first competition day of that event.
